

# PUPPY AGREEMENT

1. The price of this puppy is \_\_\_\_\_
2. Buyer agrees to have the puppy examined by a licensed veterinarian within 2 business days of delivery. A copy of the exam must be mailed to Seller; post marked 3 business days of the purchase. This is mandatory to start the 1-year warranty against inherited genetic defects. A one year after sale Replacement Warranty is given for life-threatening inherited genetic disease that would severely impact the quality of life, short of euthanasia, or caused said puppy to expire. These conditions are listed and limited to heart, kidney, and liver from the date of puppy's birth. No other conditions are included or covered in this contract. This warranty does not cover hypoglycemia, kennel cough, patella problems, hernias, pinched nostrils or diseases for which vaccinations could prevent.
3. A notarized Veterinarian Report with findings stating, to a medical certainty, that the condition or death was in fact caused from the prenatal state will be required. Buyer will be required to send the notarized Vet's Report by registered mail along with all of the puppy's medical records. Seller's Veterinarian must confirm and agree with the diagnosis. The Seller will then give Buyer a replacement puppy of equal value and the same gender, from the next available litter. Replacement Warranty will be terminated if puppy was found to be abused, neglected, or does not have records of vaccinations and fecal records, or if the dog has produced offspring. Warranty is limited to replacement of puppy only.
4. The Seller will assume no shipping costs associated with sale or Replacement Warranty.
5. Warranty applies to the original buyer only, and is not transferable.
6. The Buyer agrees that the puppy will never be placed in a shelter, rescue, or sold to a broker, pet shop or puppy mill. If the Buyer is unable to keep the puppy, the Buyer is required to contact Seller. Seller has right of first refusal and will take dog back at any time.
7. The size a puppy will grow to, as an adult, is only an estimate based on Seller's experience and trait recognition. No guarantees are made as to adult size. The Seller does not guarantee the color of said dog. Because the breed is normally double-coated, their color may become lighter or darker as they age and grow, and will almost always be lighter if the dog is shaved down, as the undercoat is lighter.
8. Buyer agrees to have puppy spayed/neutered by one year of age. **Puppy is never to be bred.** Doing so will automatically forfeit puppy and return him/her to Seller.
9. Buyer agrees that puppy will be housed inside the Buyer's home.
10. Buyer agrees to provide puppy with proper vet care, as needed.
11. Any disputes will be litigated in Tuscola County, Michigan, USA at the Buyer's expense.
